the purpose of assisting the citizens of the City of Greendale in paying for the cost of sewer lateral repair as needed?

Proposition 1 (Simple Majority Required): Shall the City of Normandy impose a sales tax at a rate of one half of one percent for economic development purposes?

Proposition 2 (Simple Majority Required): Shall the City of Normandy be authorized to impose a local use tax at the same rate as the local sales tax by a vote of the governing body, provided that if any local sales tax is repealed, reduced or raised by voter approval, the respective local use tax shall also be repealed, reduced or raised by the same action? A use tax return shall not be required to be filed by persons whose purchases from out of state vendors do not in total exceed two thousand dollars in any calendar year.
